



## MyCar Rental Agreement

NOW, THEREFORE, in consideration of the mutual promises and agreements contained herein, the parties agree as follows:

**Pick-Up Location:**

The Renter agrees to pick up the vehicle from the Host's designated location provided by RYDE MY CAR at the agreed-upon start date and time.

**Terms and Conditions:**

**1. Use of Vehicle:** The Renter is permitted to utilize the vehicle exclusively for personal use, adhering strictly to legal guidelines. The vehicle shall not be employed for any unlawful activities or purposes other than those explicitly specified within this agreement. It is expressly forbidden to engage in any activities that contravene local, state, or federal laws while operating the vehicle.

**2. Return of Vehicle:** Upon the expiration of the rental period, the Renter undertakes to surrender the vehicle to the Host's designated location, as provided by RYDE MY CAR. The vehicle must be returned in a condition equivalent to that at the commencement of the rental period, with the exception of reasonable wear and tear that occurs through ordinary usage. The Renter is obligated to return the vehicle on or before the agreed-upon end date stipulated in the rental agreement.

**3. Maintenance and Repair:** Throughout the duration of the rental period, the Renter assumes responsibility for maintaining the vehicle in a safe and roadworthy state. Any issues pertaining to the maintenance or repair of the vehicle that arise during the rental period must be promptly communicated to the Host. The Renter agrees to promptly notify the Host of any mechanical problems, damages, or malfunctions encountered during the course of usage, and to cooperate with the Host in addressing such issues in a timely manner.

**4. Insurance:** The Renter agrees to provide proof of valid insurance coverage for the duration of the rental period and to bear responsibility for any damages or losses incurred during the rental period.

**5. Security Deposit:** The Renter shall pay a sum of\$ \_\_\_\_\_ ( \_\_\_\_\_ USD) as a security deposit at the time of signing this agreement. This security deposit serves to cover any potential damages to the vehicle or outstanding fees incurred during the rental period. At the conclusion of the rental period, the security deposit will be refunded to the Renter, less any deductions for damages or outstanding fees as stipulated in this agreement.

**6. Cancellation Policy:** The Renter acknowledges and agrees to abide by the cancellation policy established for the rental agreement. This includes adherence to any stipulated time frames for cancellations and acknowledgment of any penalties or fees that may be imposed for cancellations made within the specified time frame.

**7. Condition of Vehicle:** The Renter affirms that they have conducted a thorough inspection of the vehicle and have found it to be in a satisfactory condition upon receipt. Furthermore, the Renter acknowledges that the vehicle is devoid of any pre-existing damages not duly recorded in this agreement. By signing this agreement, the Renter accepts responsibility for the condition of the vehicle for the duration of the rental period, subject to the terms outlined herein.

**8. Additional Drivers:** The Renter agrees to restrict vehicle operation solely to authorized additional drivers as explicitly agreed upon with the Host. Unauthorized drivers are expressly prohibited from operating the vehicle during the rental period. Any deviation from this provision may result in penalties or termination of the rental agreement at the discretion of the Host.

**9. Excess Mileage:** In the event that the Renter surpasses the agreed-upon mileage limit stipulated in the rental agreement, the Renter consents to pay any applicable excess mileage fees as specified within the agreement. Such fees are determined based on the distance traveled beyond the agreed-upon mileage limit and are payable at the conclusion of the rental period.

**10. Late Return:** The Renter is obligated to return the vehicle punctually as specified within the agreement. Failure to adhere to the agreed-upon return time may result in the imposition of additional fees or penalties, as outlined in the rental agreement.

**11. Accident Reporting:** In the event of any accidents, damages, or incidents involving the vehicle, the Renter agrees to promptly report such occurrences to both the Host and the relevant authorities as mandated by applicable laws and regulations. Immediate reporting ensures that necessary measures can be taken to address any resulting issues or damages.

**12. Prohibited Uses:** The Renter is expressly prohibited from engaging in any activities with the vehicle that are deemed prohibited, including but not limited to towing, off-road driving, racing, or commercial use, without obtaining prior written consent from the Host. Any unauthorized use of the vehicle for such purposes may result in penalties or termination of the rental agreement.

**13. Cleanliness:** Upon returning the vehicle, the Renter agrees to ensure that it is in a clean condition, both internally and externally. Additionally, the Renter is responsible for removing any personal belongings from the vehicle prior to its return to the Host. Maintaining cleanliness facilitates the smooth transition of the vehicle to subsequent renters and helps uphold its overall condition.

**14. Smoking and Pets:** The Renter acknowledges and agrees not to smoke or permit pets inside the vehicle without obtaining prior written consent from the Host. Furthermore, the Renter bears responsibility for any cleaning or damages incurred as a result of smoking or the presence of pets inside the vehicle during the rental period.

**15. Fuel Policy:** The Renter commits to returning the vehicle with the same level of fuel as it had at the commencement of the rental period, or alternatively, to reimburse the Host for any fuel utilized during the rental period in accordance with the agreed-upon fuel policy outlined in the rental agreement.

**16. Tolls and Fines:** The Renter accepts responsibility for any tolls, parking fees, traffic violations, or fines incurred during the rental period. Prompt notification of such charges to the Host is required, and the Renter agrees to settle any associated fees in a timely manner.

**17. Liability:** The Renter agrees to indemnify and hold the Host harmless from any claims, damages, or liabilities arising from the Renter's use of the vehicle during the rental period. This includes but is not limited to damages to the vehicle, injuries to individuals, or property damage resulting from the Renter's actions or negligence while operating the vehicle.

**18. Hold Harmless:** The Renter agrees to hold the Host harmless from any claims, liabilities, damages, losses, or expenses arising from the Renter's use of the vehicle during the rental period. This includes but is not limited to claims made by third parties, damages to property, and injuries to individuals, or any other incidents resulting from the Renter's actions, negligence, or breach of the terms outlined in this agreement. By accepting this provision, the Renter assumes full responsibility for

any consequences arising from their use of the vehicle and agrees to indemnify the Host against any resulting claims or expenses.

**19. Modifications:** The Renter agrees not to make any modifications to the vehicle without the prior written consent of the Host.

**20. Assignment:** The Renter shall refrain from assigning, transferring, or subletting any of its obligations, rights, or interests under this Agreement to any third party, whether associated or not, whether in whole or in part, without the prior written consent of the Host.

**21. Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of the state of Texas.
